**PART - III**

**(Institutions & Cases allotment)**

(1) The bail applications of Rape and Protection of Children Against Sexual Offences (POCSO) Act of the above mentioned police stations pending on the date of this order before a Court shall be retained with said Court for disposal according to Law.

(2) Second application for bail by an accused shall be assigned to same Judge by whom earlier bail application is decided on merits.

(3) In case absconding accused file any bail application, then the said bail application be allotted where the charge-sheet is pending.

(4) An application for bail in a particular crime number shall be assigned to the Court before whom earlier bail application in said crime number is pending.

(5) If an application for bail in a crime number is not pending on the date of filing of another bail application, it shall be assigned to the concern court having the Jurisdiction of the police station.

(6) All the instituted Chargesheet/Cases/final report under cases of Rape and Protection of Children Against Sexual Offences (POCSO) Act, henceforth, be allotted by Police Station-wise to the Judicial Officers as mentioned in Part-II.

(7) Once a case is **committed to the Court of Sessions**, any application for bail shall be filed before the Court in which the case is pending, irrespective of the Court which has decided earlier bail application. This would include a case of absconding accused or against whom supplementary charge sheet is not filed.

(8) In absence of an additional Sessions Judge, his charge shall be with the in-charge Court.


(9) This order be displayed on the notice board of concerned Courts.
