Applications are hereby invited in the prescribed format from eligible Advocates for empanelment as the Panel Advocate in District Legal Services Authority, Surat and Taluka Legal Service Committee, Choryasi / Bardoli / Kathor / Mandvi / Mangrol/ Mahuva/ Palsana/ Olpad/ Umarpada.

Please read following Instructions carefully before making the application:-

- The legal practitioners having minimum <u>Three years of practice as on</u>
 22.04.2022 are eligible for making the application. The Application for empanelment shall have to be made in physical form only to the concerned TLSC or DLSA, as the case may be.
- 2. The Advocates shall submit their application for the panel of Taluka Legal Service Committee, Choryasi / Bardoli / Kathor / Mandvi / Mangrol / Mahuva / Palsana / Olpad / Umarpada to the respective TLSCs and not to District Legal Services Authority, Surat. Only the Advocates, who intend to render their services as a Panel Advocate for the District Legal Services Authority, Surat, shall submit their application in physical form in the office of DLSA, Surat during the office hours.
- 3. Applications shall be accepted from **12.04.2022 to 22.04.2022** only during working hours and working days.

- 4. No application shall be entertained after the last date **i.e. 22.04.2022**.
- 5. The Advocate shall provide all particulars mentioned in the prescribed application form which is enclosed herewith along with the necessary self-attested documents, failing which his/her application shall be liable to be rejected. Application received with incomplete details shall be liable to be rejected.
- 6. No Advocate shall be called for viva voce unless he/she satisfies the eligibility criteria during the scrutiny of the Application forms. The Advocate shall have to compulsorily remain present for viva voce at his/her own cost before the concerned DLSA/TLSC.
- 7. Merely fulfilling the eligibility criteria will not confer any right on any Advocate to be called for interview or selection as a Panel Advocate.
- 8. Empanelment shall be subject to review of performance/work done by each lawyer by the DLSA/TLSC concerned.
- 9. In order to ensure that there is effective check on the Legal Services being rendered, the lawyers on the panel shall submit case-wise progress every month to the DLSA/TLSC concerned. Non-submission of the progress report, as above, would entail into removal of the Advocate from the panel.
- 10. If performance of the Panel Advocate is found unsatisfactory or the Advocate is found to be guilty of charging or collecting or demanding any remuneration from an aided person in any form whatsoever he/she contravenes the Scheme of the Act, Rules and the Regulations, he/she shall be removed from the panel and shall also be liable for action for Professional Misconduct in accordance with law.
- 11. The Advocate shall apply for empanelment for Only One Legal Services Institution i.e. District Legal Services Authority, Taluka Legal Services Committee or Family Court or Labour Court or Consumer Court or Revenue Tribunal, whichever is the major area of his/her practice in order to avoid duplication and to have convenience.

12. In case of any dispute or allegation or application pending against any Advocate, the Chairman, DLSA, Surat reserves right to reject his/her application without assigning any reasons.

13. As per the instructions given vide Letter No.1635/2018 dated 23.10.2018 of the Gujarat State Legal Services Authority, Ahmedabad, the Panel Advocate will have to invariably submit the Feedback Form and Evaluation Form at the end of the case allotted to him/her along with the copy of the Order/Judgment and effective - non effective certificate in the prescribed proforma issued by concerned court for processing payment in respect of the concerned allotted case within One (01) month from the date of Order/Judgment in the allotted Case.

- 14. The Panel Advocate shall have to be punctual in attending the Courts personally for the cases allotted to him/her as well as attending their duty as the Retainer Lawyer in the Front Office, Legal Service Clinics, Jail, Observation Home, Protection Home and for attending any other awareness and Training Programmes conducted or held by DLSA or TLSC.
- 15. The Panel Advocate will not do any kind of work against the interest of the District Legal Services Authority or Taluka Legal Services Committee and if anything is found against the interest of the institution his/her name from the Panel shall be liable to be removed.
- 16. The Panel Advocates shall be paid fees in accordance with the rules and regulations for the time being in force and instructions given by the National Legal Services Authority, New Delhi and Gujarat State Legal Services Authority, Ahmedabad.
