(3) The Bail Application where in Sessions Case is Committed (including absconding accused or whose supplementary charge-sheet is not filed) shall be allotted or filed before the same Sessions Court. Irrespective of which court decided similar bail application of concern accused.

(4) All Bail Applications of all Police Stations pertaining cases under Atrocities of Women will be entertain and decided by Smt. S. B. Rathod, District Judge-21 & Addl. Sessions Judge, Pune.

(5) In the absence of any of the above Additional Sessions Judge, the charge shall be kept with the in-charge duty courts.
